A1. Accounting Policies and Methods of Computation

The interim financial report is unaudited and has been prepared in accordance with Financial Reporting Standard ("FRS") 134 Interim Financial Reporting and Chapter 9, Part K paragraph 9.22 of the ACE Market Listing Requirements of the Bursa Malaysia Securities Berhad ("Bursa Securities").

The explanatory notes contained herein provide an explanation of the events and transactions that are significant to the understanding of the changes in the financial position and performance of the Group since the financial year ended 30 June 2011.

The accounting policies and methods of computation adopted by the Group in the interim financial statements are consistent with those adopted in the latest audited annual financial statements except for the adoption of the amendments to FRSs and Interpretation Committee ("IC") Interpretations that are applicable to the Group for the financial period beginning 1 July 2011.

The adoption of new and revised FRSs, amendments to FRSs and IC Interpretations does not have any significant impact to the financial statements of the Group.

A2. Seasonality or Cyclicality of Operations

The business operations of the Group are not materially affected by any seasonal or cyclical factors.

A3. Unusual Items

During the current financial quarter, there was no item of an unusual nature that affects the assets, liabilities, equity, net income or cash flows of the Group.

A4. Changes in Estimates of Amounts Reported

There was no significant change to estimate of amount reported in prior interim periods or prior financial years.

A5. Changes in Debt and Equity Securities

For the current financial quarter and financial year-to-date, the Company repurchased 100 and 200 ordinary shares of RM0.10 each of its issued share capital from the open market, at an average cost of RM0.88 and RM0.84 per share, respectively. The total consideration paid for the share buy-back, including transaction costs during the current financial quarter and financial year-to-date amounted to RM129.03 and RM249.06, respectively and were financed by internally generated funds. The repurchased shares are held as treasury shares in accordance with the requirements of Section 6A of the Companies Act, 1965. As at 31 March 2012, the total number of treasury shares held was 4,672,500 ordinary shares of RM0.10 each.

Apart from the above, there was no issuance, cancellation, repurchase, resale and repayment of debt and equity securities during the current financial quarter or financial year-to-date.

A6. Dividend paid

A second interim single tier dividend of 1 sen per ordinary share of 10 sen each amounting to RM13,453,276 in respect of financial year ended 30 June 2011 was paid on 24 November 2011.

Part A - Financial year-to-date review

For the nine months under review, the Group recorded revenue and profit before tax of RM63.714 million and RM59.100 million, respectively representing an increase of 23.0% and 21.6% compared to the preceding year corresponding period ended 31 March 2011. The increases were largely attributable to fee income derived from the spectrum sharing agreement in relation to the Group's 2.3GHz Worldwide Interoperability for Microwave Access ("WIMAX") spectrum.

B1. Review of Performance - continued

The performance of the respective operating segments was as follows:

i) Information technology and e-commerce ("ITeC")

Revenue reduced by 20.4% to RM4.431 million from RM5.57 million, mainly due to the absence of non-recurring project income recorded in the preceding year corresponding period. Profit before tax decreased by 82.9% from RM12.592 million to RM2.152 million, mainly due to the absence of a gain on the disposal of Extiva Communications Sdn. Bhd. ("Extiva") recorded in the preceding year corresponding period. Stripping out this gain in the previous corresponding period, profit before tax gained by 366.8% to RM2.152 million.

ii) Communications technology ("CT")

Revenue and profit before tax of RM56.366 million and RM56.885 million, respectively represented an increase of 30.9% and 60.0% compared to the preceding year corresponding period. The increases were contributed by the higher fee income from the Group's WIMAX spectrum sharing agreements.

iii) Content and digital media

Revenue and profit before tax of RM2.917 million and RM0.063 million, respectively represented a decrease of 7.7% and 86.2% compared to the preceding year corresponding period. The decrease in profit before tax was mainly due to lower digital media advertising income and a higher share of administrative expenses for period under review following the disposal of Extiva.

Part B - Current quarter review

The Group recorded a revenue and profit before tax for the current financial quarter of RM21.492 million and RM19.330 million, respectively representing a decrease of 2.0% and 35.0%, respectively compared to RM21.922 million and RM29.735 million, respectively recorded in the preceding year corresponding quarter. The decrease in profit before tax from the ITeC segment was largely due to the absence of a gain on the disposal of Extiva recorded in the preceding year's corresponding quarter. Whilst, profit before tax from the CT segment recorded a growth of 6.7% to RM19.160 million, mainly due to lower operating expenses compared to the preceding year's corresponding quarter.

On 2 May 2012, the Company announced that Infoscreen Networks Plc ("INP"), a 99.77% owned subsidiary, announced its intention to seek shareholders' approval for the cancellation of admission of its ordinary shares of 1 penny each ("Ordinary Shares") on AIM ("Delisting") at a general meeting to be held at London on 23 May 2012. The Company has provided an irrevocable undertaking to vote in favour of the resolution approving the Delisting.

INP has on 30 April 2012 notified the London Stock Exchange of the Delisting. Subject to the passing of the resolution set out in the notice of general meeting by the shareholders of INP, it is anticipated that the trading in the Ordinary Shares on AIM will cease at close of business on 30 May 2012 with the Delisting taking effect at 7.00 a.m. (London time) on 31 May 2012.
